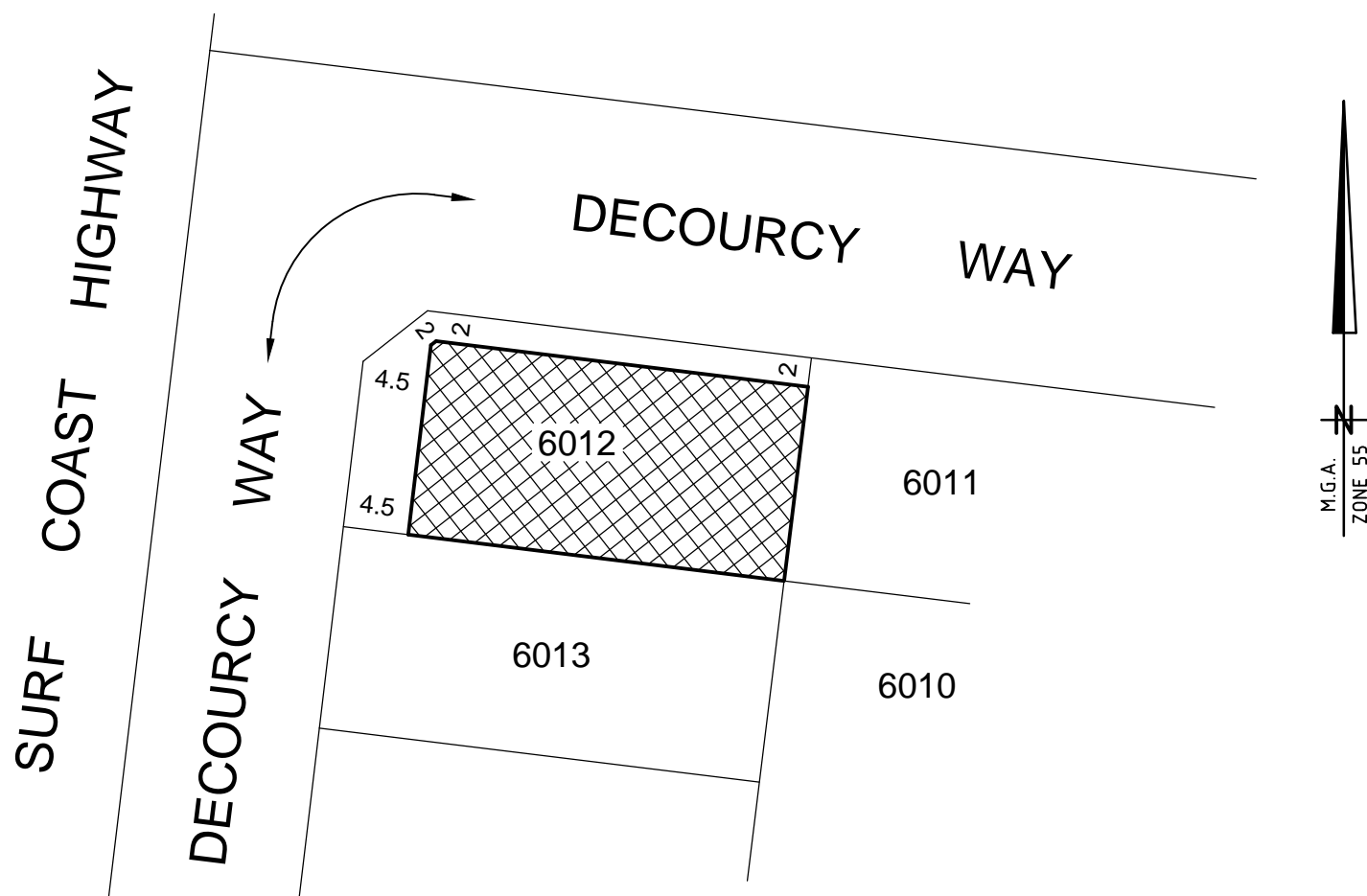

**BUILDING ENVELOPE DIAGRAM NOTATIONS**

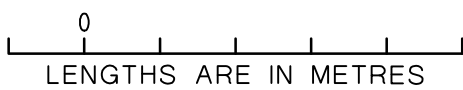
